COMPLAINT

Warrant

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Assault-2nd Degree-Dangerous Weapon

Minnesota Statute: 609.222.1

Maximum Sentence: 7 years or \$14,000 fine or both.

Offense Level: Felony

Offense Date (on or about): 10/02/2022

Control #(ICR#): 22023393

Charge Description: On or about October 2, 2022, in the County of Blue Earth, Minnesota, Paul Peter Jal, did assault another with a dangerous weapon.

COUNT II

Charge: Assault-3rd Degree-Substantial Bodily Harm

Minnesota Statute: 609.223.1

Maximum Sentence: 5 years or \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 10/02/2022

Control #(ICR#): 22023393

Charge Description: On or about October 2, 2022, in the County of Blue Earth, Minnesota, Paul Peter Jal did assault another, and inflicted substantial bodily harm,

COUNT III

Charge: Threats of Violence-Reckless Disregard Risk

Minnesota Statute: 609.713.1

Maximum Sentence: 5 years or \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 10/02/2022

Control #(ICR#): 22023393

Charge Description: On or about October 2, 2022, in the County of Blue Earth, Minnesota, Paul Peter Jal did, threaten, directly or indirectly, to commit any crime of violence with purpose to terrorize another, or in a reckless disregard of the risk of causing such terror.

COUNT IV

Charge: Emergency Telephone Calls/Communications - Interrupt, Interfere, Impede, Disrupt 911 Call

Minnesota Statute: 609.78.2(1)

Maximum Sentence: 1 year or \$3,000 fine or both

Offense Level: Gross Misdemeanor

Offense Date (on or about): 10/02/2022

Charge Description: On or about October 2, 2022, in the County of Blue Earth, Minnesota, Paul Peter Jal did and intentionally interrupt, disrupt, impede, or interfere with an emergency call or intentionally prevent or hinder another from placing an emergency call.

COUNT V

Charge: Damage to Property-4th Deg-Intentional Damage-Other Circumstances

Minnesota Statute: 609.595.3

Maximum Sentence: 90 days or \$1,000 fine, or both.

Offense Level: Misdemeanor

Offense Date (on or about): 10/02/2022

Control #(ICR#): 22023393

Charge Description: On or about October 2, 2022, in the County of Blue Earth, Minnesota, Paul Peter Jal did intentionally cause damage to another person's physical property without the other person's consent.

STATEMENT OF PROBABLE CAUSE

On October 2, 2022, at approximately 4:15 AM, officers of Mankato Department of Public Safety were dispatched to an apartment residence in Mankato, Minnesota, Blue Earth County. A 911 caller had an open line with a female screaming, a male voice, and thumping sounds.

Officers arrived at the apartment complex and made contact with Victim 1. Officers observed that Victim 1 was soaking wet head to toe in water, was actively bleeding from the nose, face was swollen to the point that officers couldn't see her eyes, and her nose was swollen. Officers entered the apartment and observed water all over the floor, broken plastic on the kitchen floor, and several cell phones that had cracks on the screen.

Victim 1 stated that she was assaulted by Paul Peter Jal. Jal got upset at Victim 1 because she was wearing an American flag shirt. Jal attacked her. Victim 1 stated that Jal grabbed her neck and restricted her airway. Jal also threw punches at her. At one point Jal attacked Victim 1.

with a towel rack that he ripped out of the wall. Officers observed a puncture wound. Victim 1 said Jal stabbed her. During the assault, Jal also threatened to kill Victim 1 and told her she would die tonight. Victim 1 called 911 on Victim 2's phone. Jal then took the phone and broke it.

Officers also spoke to Victim 2. Victim 2 stated he was sleeping and awoke to the argument between Jal and Victim 1. Victim 2 heard Jal threatened to kill Victim 1. Jal went into the bedroom Victim 2 was sleeping and hid the towel rack under the bed. Jal then left. Victim 2 then found his phone broken.

Officers found the towel rack.

Officers attempted to locate Jal but couldn't find him. A warrant is requested.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
