COMPLAINT

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Stalking - Intent to Injure

Minnesota Statute: 609.749.2(1)

Maximum Sentence: 1 year and/or \$3,000

Offense Level: Gross Misdemeanor

Offense Date (on or about): 08/27/2016

Control #(ICR#): 16025832

Charge Description: Yaasi Lee Lambert

On or about August 27, 2016, in the County of Blue Earth, said Defendant, Yaasi Lee Lambert did, directly or indirectly, or through third parties, manifest a purpose or intent to injure the person, property or rights of another by the commission of an unlawful act.

COUNT II

Charge: Stalking - Follow, monitor, pursues another

Maximum Sentence: 1 year and/or \$3,000

Offense Level: Gross Misdemeanor

Offense Date (on or about): 08/27/2016

Charge Description: Yaasi Lee Lambert

On or about August 27, 2016, in the County of Blue Earth, said Defendant, Yaasi Lee Lambert did follow, monitor, or pursues another, whether in person or through any available technological or other means.

COUNT III

Charge: Assault-5th Degree-Fear of Bodily Harm or Death

Minnesota Statute: 609.224.1(1)

Maximum Sentence: 90 days and/or \$1,000

Offense Level: Misdemeanor

Offense Date (on or about): 08/27/2016

Charge Description: Yaasi Lee Lambert

On or about August 27, 2016, in the County of Blue Earth, said Defendant, Yaasi Lee Lambert did commit an act with intent to cause fear in another of immediate bodily harm or death.

COUNT IV

Charge: Assault-5th Deg-Inflict or Attempt Bodily Harm

Minnesota Statute: 609.224.1(2)

Maximum Sentence: 90 days and/or \$1,000

Offense Level: Misdemeanor

Offense Date (on or about): 08/27/2016

Control #(ICR#): 16025832

Charge Description: Yaasi Lee Lambert

On or about August 27, 2016, in the County of Blue Earth, said Defendant, Yaasi Lee Lambert did intentionally inflict or attempted to inflict bodily harm upon another.

STATEMENT OF PROBABLE CAUSE

Officer Jesse Gilbertson, a licensed police officer in the State of Minnesota, currently employed by the Mankato Department of Public Safety, reports that on August 27, 2016, at approximately 9:50 p.m., he responded to a residence in the City of Mankato for a reported assault that had just occurred. Gilbertson reports he arrived at the residence and made contact with several persons in the apartment. The primary complainant, identified as Witness 1, said that her daughter, identified as Victim 1, had been assaulted by Yassi Lambert.

Officer Gilbertson spoke with Victim 1, who stated that she and the others had been swimming and they had come back to her friend's sister's apartment and were hanging out. Victim 1 stated that she and her friend, identified as Witness 2, were at the apartment with Lambert, his girlfriend, and Witness 2's sister, identified as Witness 3. Additionally, the renter of the apartment, identified as Witness 4, was present, along with a friend of Lambert's.

Victim 1 reports that she and Witness 3 were talking back to each other in a joking way and were making fun of each other. Lambert became upset with that and told Victim 1 that he sticks up for his girl and will 'hit bitches'.

Victim 1 reports she then put a small amount of peanut butter on Lambert's face and he became upset. Victim 1 stated she did this because they had been doing this to her friend's dog, who would then lick it off.

After the peanut butter was applied, Victim 1 reports Lambert jumped on top of her and began choking her. Victim 1 stated that she could breathe if she took a deep breath but that Lambert hurt her neck by grabbing her and attempting to choke her. Victim 1 reports that at some point, Lambert got peanut butter and rubbed it in her hair.

Victim 1 reports she was able to get up and run to the bathroom to try and get the peanut butter out. She stated that Lambert followed her, picked up a cell phone cable, and hit her with it. She reports she did not know how many times she had been hit but it was a lot. Victim 1 stated that she was able to run outside to try to hide from Lambert; however, he followed her outside with the cable and chased her.

Victim 1 reports that both Witness 2 and Witness 4 witnessed the incident. Additionally, Officer Gilbertson reports that he observed several red marks that had become welts on Victim 1's legs and back. Victim 1 stated that she never hit Lambert but that she pushed him to get away from him.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
