COMPLAINT

Summons

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Assault-5th Deg-Inflict or Attempt Bodily Harm

Minnesota Statute: 609.224.1(2)

Maximum Sentence: 90 days and/or \$1,000

Offense Level: Misdemeanor

Offense Date (on or about): 04/17/2016

Control #(ICR#): 16011278

Charge Description: Said Defendant, Amy Rose Villwock, did intentionally inflict or attempt to inflict bodily harm upon another.

COUNT II

Charge: Disorderly Conduct-Brawling or Fighting

Minnesota Statute: 609.72.1(1)

Maximum Sentence: 90 days and/or \$1,000

Offense Level: Misdemeanor

Offense Date (on or about): 04/17/2016

Control #(ICR#): 16011278

Charge Description: Said Defendant, Amy Rose Villwock, did in a public or private place, knowing, or having reasonable grounds to know that it will, or will tend to, alarm, anger or disturb others or provoke an assault or breach of the peace, engaged in brawling or fighting.

STATEMENT OF PROBABLE CAUSE

Complainant is an Officer with the Mankato Police Department who believes the information set out below is true and accurate based on reports and information submitted to the Officer by Officer Steven Hoppe and others identified herein.

On April 17, 2016, at about 6:26 p.m., an identified person called the police and requested a welfare check on a female party they had picked up and given a ride to a residence on Main Street in Mankato, Blue Earth County. The reporting party stated that the female told them she had just been assaulted by her brother. Officers Kaiser and Hoppe arrived at the residence and spoke with V1 and her mother, W1. V1 was holding an ice pack to her left eye, and the officers could see a small bump and the beginnings of bruising. Additionally, they observed a red handprint on her arm where she stated she had been grabbed by her brother, Christopher Lyle Villwock, the Defendant. V1 stated she was riding in a car driven by W1 and was seated in the backseat with the Defendant and their young sister. She reported that she told the Defendant to stop swearing in front of the younger child and he became upset. V1 and the Defendant began arguing, and the Defendant punched her in the left eye with a closed fist. V1 then tried to get out of the car, and the Defendant grabbed her by the arm to keep her in the vehicle. V1 was able to get out and started walking when she was offered a ride to the residence on Main Street. Officer Hoppe spoke with the Defendant at his residence. He admitted that he grabbed V1 by the arm to keep her in the car and that he hit her in the face. He stated he was acting in self-defense.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
