The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Fugitive from Justice from Other State

Minnesota Statute: 629.13

On or about August 31, 2016, in the County of Blue Earth, said Defendant, Justin Dean Hudson, is a fugitive from justice in that Justin Dean Hudson is present in Blue Earth County, Minnesota and have been charged with the commission of a crime in any other state and having fled from justice, or having been convicted of a crime in another state and having escaped from confinement, broken the terms of bail, probation, or parole, and the State of South Dakota has issued a warrant for the defendant's arrest and demanded the defendant's return.

STATEMENT OF PROBABLE CAUSE

Complainant makes complaint to the undersigned Judge of the above-named Court pursuant to Minnesota Statutes 629.13, 629.14, and 629.15 for Court determination of probable cause to support an Order of Detention for the above-named Defendant, as follows:

Complainant is a licensed peace officer for the State of Minnesota and is a Deputy Sheriff for Blue Earth County.

Complainant has received a teletype or facsimile or verbal report, from the County of Minnehaha, State of South Dakota, alleging that the above-named Defendant has committed a crime in said state and fled from justice.

The Defendant, Justin Dean Hudson, date of birth July 17, 1993 was charged with a three counts Felony Rape 4th-Victim 13/Less than 16 and Sexual Contact with Child Under 16-Actor More/Three Years. Said crimes are Class 3 Felonies punishable in said state by death or imprisonment of a term exceeding one year.

The Defendant is current in the custody of the State of Minnesota at the Blue Earth County Jail. The State of South Dakota has confirmed that they will extradite the Defendant from Minnesota.
