COMPLAINT

Summons

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Drugs - 5th Degree - Sale - Marijuana Mixture Except Small Amount of Marijuana with No Remuneration

Minnesota Statute: 152.025.1(a)(1)

Maximum Sentence: 5 years and/or \$10,000

Offense Level: Felony

Offense Date (on or about): 12/07/2015

Control #(ICR#): 15038637

Charge Description: Jarod Sidney Jackson

On or about December 7, 2015, in the County of Blue Earth, said Defendant, Jarod Sidney Jackson did unlawfully sell one or more mixtures containing marijuana or Tetrahydrocannabinols, except a small amount of marijuana for no remuneration.

STATEMENT OF PROBABLE CAUSE

On December 7, 2015, Agent Huettl of the Minnesota River Valley Drug Task Force was in contact with a confidential informant (CI). CI advised that CI was able to purchase marijuana from a source known to them as 'Jared.' Agents were able to identify 'Jared' as Jarod Sidney Jackson (D.O.B. 10/08/1993). CI advised that CI has known Jackson for approximately eight to nine months and had bought from Jackson on a regular basis.

Agent Huettl met with CI prior to the controlled purchase and had CI set up a purchase of marijuana from Jackson. Prior to the controlled purchase, CI was searched for contraband or controlled substances. The CI was also fitted with an audio transmitting and recording device and provided with pre-recorded buy-fund money. A preoperational briefing was held and assignments were given to other personnel. Agents were placed in position to observe the deal. CI then received a text message from Jackson stating that Jackson had just arrived home and that Jackson was able to come over. Agents observed the following: At 7:21 p.m., CI arrived at Jackson's apartment complex in the City of Mankato and parked in the lot. CI sent Jackson a text advising that CI is there and received a text back from Jackson. Jackson is observed leaving his apartment and meeting with CI. At 7:26 p.m., the deal is completed and CI leaves the parking lot.

Upon completion of the deal, Agent Huettl met with CI at a predetermined location and took custody of a plastic bag containing a green leafy substance that field-tested positive for marijuana. The total weight of the substance on a noncertified scale was 4.1 grams. CI was searched again and no contraband or controlled substances were located. Agent Huettl then conducted a debrief with the CI. CI advised that CI had contacted Jackson via text message. Jackson contacted the CI to let CI know that CI could come over. CI arrived at Jackson's apartment complex and sent a text to Jackson. Jackson came out and met with CI in CI's vehicle. CI provided Jackson with the buy-fund money and Jackson gave CI the marijuana.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
