COMPLAINT

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Theft-Take/Use/Transfer Movable Prop-No Consent

Minnesota Statute: 609.52.2(a)(1), with reference to: 609.52.3(4)

Maximum Sentence: 1 year and/or \$3,000

Offense Level: Gross Misdemeanor

Offense Date (on or about): 09/05/2016

Control #(ICR#): 16026869

Charge Description: Said Defendant, Kristie Lynn Harroun, Also Known As Kristi Harroun, Lisa Marie Senese And Kristi Lynn Harroun, did intentionally and without claim of right take, use, transfer, conceal or retain possession of movable property of another without the other's consent and with intent to deprive the owner permanently of possession of the property, such property being worth more than \$500 but less than \$1001.

COUNT II

Charge: Give Peace Officer False Name/Birthdate/ID Card

Minnesota Statute: 609.506.1

Maximum Sentence: 90 days and/or \$1,000

Offense Level: Misdemeanor

Offense Date (on or about): 09/05/2016

Control #(ICR#): 16026869

Charge Description: Said Defendant, Kristie Lynn Harroun, Also Known As Kristi Harroun, Lisa Marie Senese And Kristi Lynn Harroun, with intent to obstruct justice, gave a fictitious name other than a nickname, or did give a false date of birth, or false or fraudulently altered identification card to a peace officer, as defined in section 626.84, subdivision 1, paragraph (c), when that officer makes inquiries incident to a lawful investigatory stop or lawful arrest, or inquiries incident to executing any other duty

imposed by law.

STATEMENT OF PROBABLE CAUSE

Complainant is an Officer with the Mankato Police Department who believes the information set out below is true and accurate based on reports and information submitted to the Officer by Officer Eric Lopez and others identified herein.

Officer Lopez, a licensed peace officer in state of Minnesota, currently employed by the Mankato Department of Public Safety, reports that on September 5, 2016, at approximately 1:50 p.m., he was informed by Blue Earth County Dispatch that Target, located in the City of Mankato, had an adult female in custody for shoplifting.

Lopez reports upon his arrival he was able to identify the individual in custody as Kristie Lynn Harroun. Lopez reports Harroun did not initially provide him with her correct name and instead gave him the name of Emily Marie Emery. Officer Lopez reports when he attempted to confirm that name through dispatch it came back as 'not on file.'

Lopez reports after he was able to positively identify Harroun, she did admit to the theft of merchandise from Target.

Officer Lopez was then informed by Target asset protection that Harroun had been selecting multiple items, placing them in a shopping cart and then pushed the cart with the items in it past all points of sale.

Additionally, Lopez notes the aggregate value of the stolen items was \$657.96.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
