Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Assault-5th Deg-2/More Prev Convict in 3 years**

Minnesota Statute: 609.224.4(b)

Maximum Sentence: 5 years and/or \$10,000

Offense Level: Felony

Offense Date (on or about): 10/17/2015

Control #(ICR#): 15032648

Charge Description: Mark Warren Pritchard Also Known As Mark Warren Pritchad, Mark Pritchard, Mark Warren Pritchard, Mark E Pritchard And Mark Warren Prichard

On or about October 17, 2015, in the County of Blue Earth, said Defendant, Mark Warren Pritchard did commit an act with intent to cause fear in another of immediate bodily harm or death and has two or more previous qualified domestic violence related offense convictions or adjudications of delinquency within the previous three years.

years.

**Charge: Disorderly Conduct-Offensive/Abusive/Noisy/Obscene**

Maximum Sentence: 90 days and/or \$1,000

Offense Level: Misdemeanor

On or about October 17, 2015, in the County of Blue Earth, said Defendant, Mark Warren Pritchard did, in a public or private place, knowingly, or having reasonable grounds to know it will, or will tend to, alarm, anger or disturb others or provoke an assault or breach of the peace, engaged in offensive, obscene, abusive, boisterous, or noisy conduct or in offensive, obscene, or abusive language tending reasonably to arouse alarm, anger, or resentment in others.

### COUNT IV

**Charge: Disruptive Intoxication**

Offense Level: Misdemeanor

On or about October 17, 2015, in the City of Mankato, County of Blue Earth, said Defendant, Mark Warren Pritchard, did, in a public place, while intoxicated, conduct himself or herself so as to be a danger to themselves or others and/or engaged in public disruption.

## STATEMENT OF PROBABLE CAUSE

On October 17, 2015, at approximately 4:32 p.m., Officer Dan Grassman of the Mankato Department of Public Safety was dispatched to the Walgreen's store on Warren Street in Mankato, Blue Earth County, on the report of an intoxicated male party that was sleeping in the bushes in front of the business.

Upon arriving at the scene, Officer Grassman made contact with the male, who was later identified as Mark Warren Pritchard, D.O.B. 6-4-1963, who was sleeping or passed out at the location. Officer Grassman observed that Pritchard smelled heavily of alcohol and body odor. Officer Grassman attempted to wake up Pritchard by giving him sternum rubs. Pritchard would open his eyes and flail his arms and told Officer Grassman, "fuck off." After doing this several times, Pritchard eventually sat up. There were other people in the area while Pritchard was doing this.

It was decided that Pritchard should be taken to detox based on his condition. Officer Hoppe transported Pritchard to the Blue Earth County Jail. Upon arriving at the jail, jail staff attempted to have Pritchard sit in a wheelchair; however, Pritchard became violent and started kicking at the officers and the chair. Pritchard kicked the chair into a custody officer. Staff then took Pritchard to the ground. After getting Pritchard into his cell, he began to urinate on the door.

A record check revealed Pritchard has two previous qualified domestic violence-related offense convictions within three years. Pritchard was convicted of fourth degree assault in court file 07-CR-4-2369 in September 2014. Pritchard was convicted of violating a harassment restraining order in court file 46-CR-13-908 in September 2013.

## SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:  
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or  
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
