COMPLAINT

Warrant

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Predatory Offender-Knowingly Violates Registration Req. or Intentionally Provides False Information

Minnesota Statute: 243.166.5(a), with reference to: 243.166.5(c)

Maximum Sentence: 5 years and/or \$10,000

Offense Level: Felony

Offense Date (on or about): 03/16/2016

Control #(ICR#): 16007443

Charge Description: Kayla Jo Henry-Heagle Also Known As Kayla Henry-Heagle

On or about March 16, 2016, in the County of Blue Earth, said Defendant, Kayla Jo Henry-Heagle, did, as a predatory offender, fail to provide the information required by MN ST. 243.166 Subd. 4a, including the year, model, make, license plate number, and color of all motor vehicles owned or regularly driven by the person, to a corrections agent or law enforcement authority, within five days.

COUNT II

Charge: Drugs - 5th Degree - Possess Schedule 1,2,3,4 - Not Small Amount Marijuana

Minnesota Statute: 152.025.2(a)(1)

Maximum Sentence: 5 years and/or \$10,000

Offense Level: Felony

Offense Date (on or about): 03/16/2016

Control #(ICR#): 16007443

Charge Description: Kayla Jo Henry-Heagle Also Known As Kayla Henry-Heagle

On or about March 16, 2016, in the County of Blue Earth, said Defendant, Kayla Jo Henry-Heagle did

unlawfully possess one or more mixtures containing a controlled substance classified in schedule I, II, III, or IV, except a small amount of marijuana.

STATEMENT OF PROBABLE CAUSE

On March 16, 2016, officers with the Mankato Department of Public Safety were investigating a crime that had occurred earlier in the day. During the course of the investigation, officers observed a gray 2013 Ford Fusion bearing Minnesota license plate 387-RRK. Said vehicle's title has Kayla Jo Henry-Heagle, D.O.B. 8-21-1991, registered as an owner. Officers also had information that Henry-Heagle and her boyfriend had been in the vehicle earlier that morning. Officers executed a search warrant at Henry-Heagle's Lake Crystal, Minnesota, address and located said vehicle. When officers executed a search warrant on Henry-Heagle's vehicle, officers located 27 orange and white pills visually identified as Vyvanse 30 mg prescription pills in an unlabeled prescription pill bottle inside the glove box of the vehicle. Vyvanse (lisdexamfetamine) is a Schedule II controlled substance.

Officer Stoltman of the Mankato Department of Public Safety spoke with Henry-Heagle. Henry-Heagle acknowledged she owned a gray 2013 Ford Fusion with Minnesota license plates. A review of Henry-Heagle's criminal history indicates that she is required to register as a predatory offender following a September 18, 2013 conviction for dissemination of child pornography as set forth in Dakota County Court File No. 19HA-CR-12-4459. A review of Henry-Heagle's predatory offender registration records indicates that she has not registered the 2013 Ford Fusion as required by statute.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.

Complainant declares under penalty of perjury that everything stated in this document is true and correct. Minn. Stat. § 358.116; Minn. R. Crim. P. 2.01, subds. 1, 2.
