The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Giving Peace Officer False Name-of Another Person**

Minnesota Statute: 609.506.2

Maximum Sentence: 1 year and/or \$3,000

Offense Level: Gross Misdemeanor

Offense Date (on or about): 09/12/2016

Control #(ICR#): 16001811

Charge Description: Megan Kristine Boyd

On or about September 12, 2016, in the County of Blue Earth, said Defendant, Megan Kristine Boyd did, with intent to obstruct justice, give the name and date of birth of another person to a peace officer when that officer makes inquiries incident to a lawful investigatory stop or lawful arrest, or inquiries incident to executing any other duty imposed by law.

**COUNT II**

**Charge: Disorderly Conduct-Brawling or Fighting**

Minnesota Statute: 609.72.1(1)

Maximum Sentence: 90 days and/or \$1,000

Offense Level: Misdemeanor

Offense Date (on or about): 09/12/2016

Control #(ICR#): 16001811

Charge Description: Megan Kristine Boyd

On or about September 12, 2016, in the County of Blue Earth, said Defendant, Megan Kristine Boyd did, in a public or private place, knowingly, or having reasonable grounds to know it will, or will tend to, alarm,

anger or disturb others or provoke an assault or breach of the peace, engaged in brawling or fighting.

### COUNT III

**Charge: Liquor-Consumption by persons under 21**

Minnesota Statute: 340A.503.1(a)(2), with reference to: 340A.703

Maximum Sentence: 90 days and/or \$1,000

Offense Level: Misdemeanor

Offense Date (on or about): 09/12/2016

Control #(ICR#): 16001811

Charge Description: Megan Kristine Boyd

On or about September 12, 2016, in the County of Blue Earth, said Defendant, Megan Kristine Boyd did, while under the age of 21 years, consume an alcoholic beverage.

## STATEMENT OF PROBABLE CAUSE

On September 12, 2016, at approximately 12:40 a.m., Officer Rands responded to a report of an altercation outside of the American Legion Bar, in the City of Eagle Lake, Blue Earth County, Minnesota. Officer Rands identified the three individuals involved as Witness 1; Witness 2; and Megan Kristine Boyd, the Defendant herein. Officer Rands observed that the Defendant was holding onto the hair of Witness 1. Witness 1 is an employee at the American Legion Bar. Officer Rands heard Witness 1 tell the Defendant, 'Let go of my hair!' When Officer Rands first attempted to identify the Defendant, she identified herself as Samantha Jo Boyd. The Defendant indicated that her birthdate was 04/05/1993. When asked again for her name and date of birth, the name provided the same name, but a date of birth of 04/08/1996. When asked why she gave Officer Rands a different birthdate, the Defendant stated she was drunk and that it was a mistake. (In actuality, the Defendant told the truth and provided her actual date of birth.)

Officer Rands spoke with Witness 2 regarding the incident. Witness 2 is the Defendant's roommate. Witness 2 informed Officer Rands that the Defendant was not giving her real name or date of birth. Witness 2 informed Officer Rands that the Defendant's correct name was Megan Kristine Boyd, and that her actual birthdate was 04/08/1996. Witness 2 said that the Defendant had been using her sister's driver's license for the past three months to order drinks from the Legion. Officer Rands confronted the Defendant with the information that he learned. The Defendant started to walk away. When Officer Rands attempted to escort the Defendant back to his squad car, the Defendant's resistance became stronger. The Defendant later claimed that she had sprained her ankle and could not walk. Officer Rands spoke with Witness 2 regarding the incident. Witness 2 reported she was trying to get the Defendant home when the Defendant started hitting her. Witness 2 said that the Defendant began putting her hands on her throat. Witness 1 intervened and stepped in between Witness 2 and the Defendant. The Defendant then began hitting Witness 1.

Initially, the Defendant would not give a PBT. Blue Earth County Sheriff's Deputy Justin Lindmeyer assisted in this investigation. Deputy Lindmeyer was able to calm the Defendant down in order to get a PBT. The results of the portable breath test were .215 alcohol concentration. The defendant was 20 years old at the time of this incident.

A computer check of the Defendant's prior criminal history indicates that she has a conviction for Underage Consumption and Underage Possession from an incident on October 26, 2014. See Blue Earth County District Court File 07-VB-14-6636.

## SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:  
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
