The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Drugs - 1st Degree - Sale - 10 Grams or More-Cocaine/Heroin/Meth w/in 90-Day Period

Minnesota Statute: 152.021.1(1), with reference to: 152.021.3(b)

Maximum Sentence: Not less than four years nor more than 40 years and/or \$1,000,000

Offense Level: Felony

Offense Date (on or about): 04/13/2016

Control #(ICR#): 16004819

Charge Description: Chad Michael Ryan

On or about April 13, 2016, in the County of Blue Earth, said Defendant, Chad Michael Ryan did, within a 90-day period, unlawfully sell one or more mixtures of a total weight of ten grams or more containing cocaine, heroin, or methamphetamine; and said defendant was previously convicted of a controlled substance crime.

COUNT II

Charge: Drugs - 2nd Degree - Possess 6 Grams or More Cocaine/Heroin/Meth

Minnesota Statute: 152.022.2(a)(1), with reference to: 152.022.3(b)

Maximum Sentence: Mandatory Minimum Sentence: Not less than three years nor more than 40 years and \$500,000

Offense Level: Felony

Offense Date (on or about): 04/13/2016

Control #(ICR#): 16004819

Charge Description: Chad Michael Ryan

On or about April 13, 2016, in the County of Blue Earth, said Defendant, Chad Michael Ryan, did

unlawfully possesses one or more mixtures of a total weight of six grams or more containing cocaine, heroin or methamphetamine; and said defendant was previously convicted of a controlled substance crime.

STATEMENT OF PROBABLE CAUSE

On April 13, 2016, Agent Sam McGinnis, of the Minnesota River Valley Drug Task Force obtained a lawful search warrant for 18762 541st Street, in Blue Earth County. The search warrant was granted after a known drug transaction sale took place at this residence involving Chad Michael Ryan, date of birth January 7, 1967. The warrant was signed by The Honorable Judge Jass. At approximately 9:00 p.m. that day the search warrant was executed and the resident, identified as Ryan, was located outside of the residence near a utility shed. Ryan was taken into custody without incident.

Agent Nick Smith spoke to Ryan after he was taken into custody. Agent Smith read Ryan his Miranda Rights and explained why he was being detained. Agent Smith asked Ryan if he had any knowledge of drugs inside the residence. Ryan stated there were some inside a drawer located in the kitchen and possibly more in the bedroom.

While agents were searching the residence they found a plastic baggy containing a white crystal substance that later field tested positive for methamphetamine. The substance weighed approximately 18.7 grams. While searching the residence, agents also found a digital scale that had residue on it that field-tested positive for methamphetamine and a small plate containing residue that field-tested for methamphetamine. All the items were located in the same kitchen drawer as the 18.7 grams of methamphetamine. Next to these items was \$80 in US currency.

In Ryan's bedroom agents found three glass smoking pipes containing residue that tested positive for methamphetamine, a plastic baggy containing residue that field-tested positive for methamphetamine, and a black LG smart phone. Agents located \$283 in US currency in Ryan's pockets.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
