The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Domestic Assault-Misdemeanor-Intentionally Inflicts/Attempts to Inflict Bodily Harm on Another**

Minnesota Statute: 609.2242.1(2)

Maximum Sentence: 90 days and/or \$1,000

Offense Level: Misdemeanor

Offense Date (on or about): 12/26/2015

Charge Description: Davida Marie Depyper Also Known As Dede Davis, Vicky Douglas, Davida Marie Depyper And Davida Marie Davis

On or about December 26, 2015, in the County of Blue Earth, said Defendant, Davida Marie Depyper did, against a family or household member, as defined in M.S.A. 518B.01 Subd. 2, intentionally inflict or attempt to inflict bodily harm upon another.

## STATEMENT OF PROBABLE CAUSE

On December 26, 2015, Davida Marie Depyper called 911 stating that Steven Glen Danberry, who lives in the same residence as her, had attacked her and that she had hit him back. Depyper stated she was waiting outside in her socks to speak with law enforcement. Deputy Luanne Anderson from the Blue Earth County Sheriff's Office responded and Officer Ryan Frederick with the Lake Crystal Police Department assisted.

Upon arriving at the scene, Deputy Anderson asked Danberry what had happened. He stated that Depyper freaked out because he was smoking inside the residence. Danberry stated that she had punched him in the nose and he hit her in the back of the head as she went out the door. At that time, Deputy Anderson saw Depyper peek her head out of the door and start hollering.

Deputy Anderson then went to speak with Depyper, who was visibly upset. She stated that Danberry had been 'bitching and moaning' all day about things. She stated that he just sits on the couch all day long, either sleeping or doing nothing. Depyper stated that she was sitting on the couch with her back to the kitchen and Danberry grabbed her by the hair. She stated that she fell off the couch and on to the ground and they were wrestling around on the floor and his nose could have hit something. She stated she then got up and he hit her in the back of the head as she was exiting the house.

Officer Frederick spoke with Danberry outside of the home. He noted that Danberry had blood on the right side of his nose. He asked what the blood was from and Danberry stated that Depyper hit him in the eye and that she hit him first. He stated he was inside smoking a cigarette when she began yelling at him for smoking inside. Danberry stated that the two began yelling and that she punched him in the eye. He stated that as she was walking out the door, he slapped her on the back of the head but not very hard.

## SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:  
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or  
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
