The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Drugs - 2nd Degree - Sale Methamphetamine/Amphetamine School/Park/Public Housing Zone**

## STATEMENT OF PROBABLE CAUSE

On March 22, 2016, Agent Sam McGinnis, of the Minnesota River Valley Drug Task Force, had a confidential reliable informant (CRI) contact John Dillon Wood Neitge, date of birth November 10, 1993, to setup a controlled purchase for two ounces of marijuana and two hits of acid for \$505.00. The CRI set the purchase up for approximately 2:00 p.m., and it was to take place in the parking lot of the Super America, in Mankato, Blue Earth County.

Agent McGinnis accompanied the CRI in an undercover capacity. Agent McGinnis was fitted with an electronic monitoring device and possessed \$505.00 in prerecorded buy fund money. At approximately 1:54 p.m., Agent McGinnis observed Neitge pull into the Super America parking lot in a red Toyota Corolla. The Drug Task Force had contacted surveillance on Neitge on the previous day and knew he usually drove this vehicle. Agent McGinnis also saw Neitge in the driver's seat and knew what he looked like from his Minnesota driver's license photo.

Neitge went around to the passenger side of his vehicle and retrieved a blue backpack and entered Agent McGinnis's vehicle through the back driver's side door. Neitge reached into his backpack and pulled out two Ziploc baggies containing a green leafy substance. Neitge handed Agent McGinnis a small gem-style baggie with the numbers 420 in red lettering stamped on the side. The gem-styled baggies contained two hits/tabs of purported acid wrapped in tinfoil. Neitge stated the acid was good. Neitge also stated the marijuana is really good and he always has some on hand if needed. Agent McGinnis asked Neitge the price for both. Neitge stated it would be \$505.00. Agent McGinnis handed Neitge \$505.00 in prerecorded buy fund money. Neitge asked Agent McGinnis when Agent McGinnis thought he would need more, and Agent McGinnis responded probably next week. Neitge then exited Agent McGinnis's care and drove away.

The green leafy substance later field-tested positive for marijuana and weighed approximately 59.5 grams. The blotches of acid had serrated edges which are consistent with how acid is usually packaged.

Agent Ruch was conducting surveillance during the operation. After the controlled purchase was complete, Agent Ruch was able to follow Neitge to Neitge's residence. Agent Ruch verified that Neitge drove directly to Neitge's residence without stopping or meeting with any other people. Neitge then pulled into his residence in Mankato, Blue Earth County, and went inside.

Later that same day, Agents of the Minnesota River Valley Drug Task Force received a search warrant signed by the Honorable Judge Bradley Walker allowing a search of Neitge's residence, at 424 E Main St in Mankato, Blue Earth County, which is located within a school zone. Upon arriving at the residence, officers attempted to make contact; however, there was no answer. Officers then forced entry into the apartment and found three individuals inside that included Neitge; Adult1; and Ashley Marie Ybarra, date of birth October 21, 1992.

Agents searched Neitge's room and found five silicone containers containing purported marijuana wax that later field-tested positive for marijuana, a black Motorola Nexis cellphone, residency documents showing Neitge's name and address, a digital scale, and gem-style baggies with the numbers 420 stamped in red on the side.

Officers located a safe in an adjacent spare bedroom. Neitge informed the officers that it was his safe and willingly gave the officers the combination. Inside the safe officers found a digital scale; \$3766.00 in U.S. currency; a white powdery substance in a plastic container that later field-tested positive for methamphetamine, weighing approximately 2.3 grams; a large amount of a green leafy substance that

field-tested positive for marijuana and weighed approximately 242.3 grams.

In another bedroom officers found another backpack on the bed that contained three tablets that initially could not be identified. Ybarra's Minnesota identification card was also in the bag. Ybarra was asked about the tablets, and she stated they were ecstasy tablets and that they belonged to her.

In the downstairs living room, officers found two glass jars containing a green leafy substance that field-tested positive for marijuana and weighed approximately 152.2 grams. Officers were also able to locate \$500.00 of the prerecorded buy fund money.

## SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:  
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or  
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
