Summons

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Criminal Sex Conduct-2nd Degree-Personal Injury-Force/Coerce

Minnesota Statute: 609.343.1(e)(i), with reference to: 609.343.2(a)

Maximum Sentence: 25 years and/or \$35,000

Offense Level: Felony

Offense Date (on or about): 01/01/2016 to 03/07/2016

Control #(ICR#): 16004200

Charge Description: Timothy Garth Hansen, Jr Also Known As Timothy Garth Hanson, Jr. And Timothy Garth Hanson

On or between January 1, 2016 and March 7, 2016, in the County of Blue Earth, said Defendant, Timothy Garth Hansen, Jr did engage in sexual contact with another person and the actor causes personal injury to the complainant and the actor used force or coercion to accomplish the sexual contact.

On or between January 1, 2016 and March 7, 2016, in the County of Blue Earth, said Defendant, Timothy Garth Hansen, Jr did engage in sexual penetration with another person and the actor knew or had reason to know that the complainant was mentally impaired, mentally incapacitated or physically helpless.

Charge: Domestic Assault - By Strangulation

On or about February 25, 2016, in the City of Mankato, in the County of Blue Earth, said Defendant, Timothy Garth Hansen, Jr, did, assault a family or household member by strangulation.

Charge: Domestic Assault-Misdemeanor-Intentionally Inflicts/Attempts to Inflict Bodily Harm on Another

Maximum Sentence: 90 days and/or \$1,000

Offense Level: Misdemeanor

On or about March 6, 2016, in the County of Blue Earth, said Defendant, Timothy Garth Hansen, Jr did, against a family or household member, as defined in M.S.A. 518B.01 Subd. 2, intentionally inflicted or attempt to inflict bodily harm upon another.

COUNT VII

Charge: Domestic Assault-Commits Act to Cause Fear of Immediate Bodily Harm or Death

Minnesota Statute: 609.2242.1(1)

Maximum Sentence: 90 days and/or \$1,000

Offense Level: Misdemeanor

Offense Date (on or about): 03/06/2016

Charge Description: Timothy Garth Hansen, Jr Also Known As Timothy Garth Hanson, Jr. And Timothy Garth Hanson

On or about March 6, 2016, in the County of Blue Earth, said Defendant, Timothy Garth Hansen, Jr did, against a family or household member, as defined in M.S.A. 518B.01 Subd. 2, commit an act with intent to cause fear in another of immediate bodily harm or death.

STATEMENT OF PROBABLE CAUSE

On March 31, 2016 at approximately 10:32 AM Detective Jeremy Brennan with the Blue Earth County Sheriff's Office met with V1 regarding a sexual assault. V1 reported that she was sexually and physically assaulted by her boyfriend who would be identified as Timothy Garth Hansen, Jr.

V1 informed Detective Brennan that she has been in a relationship with Hansen since January 2016. V1 stated that during the beginning of the relationship she was living in the city of Mankato. V1 stated that she would stay with Hansen at his trailer in the county. V1 stated that the first night she stayed at Hansen's residence she woke up in the middle of the night and felt numb and out of it and she saw Hansen putting her clothes back on. V1 stated she tried to figure out what was going on and Hansen told her that they had just had sex. V1 told Detective Brennan that she did not remember ever having sex with Hansen that night.

V1 informed Detective Brennan that she can remember being sexually assaulted by Hansen seven other times in February 2016. V1 stated she remembered waking up one time feeling out of it and numb and that Hansen had his fingers in her vagina and that V1 physically couldn't even ask him what he was doing. V1 stated the next day she felt scared because she couldn't remember if it was a dream or if it happened. V1 stated that another time she woke up and Hansen was penetrating her anus with his fingers. V1 again felt like she was out of it and couldn't move ' like she had been drugged. V1 stated she heard from other people that Hansen has drugged his girlfriends in the past.

V1 reported that on February 25th 2016, Hansen found out that she had been using methamphetamine and got mad at her. V1 knew that Hansen was going to assault her and tried to get away. V1 stated she ran out of her residence and Hansen caught her in the driveway in front of her car. V1 stated that Hansen wrapped his arm around her neck and squeezed it so hard she started seeing stars and could not breathe. V1 stated she ended up passing out and was out for one minute and when she came to Hansen was trying to pick her up off the ground.

V1 stated that on March 6, 2016 she was lying down when Hansen told her to roll over and she told him no. V1 stated that Hansen then grabbed her ankle and began twisting it to get her to roll over. V1 stated she was screaming at him to stop when she heard something pop in her ankle. V1 stated that it hurt and she called a friend to come and get her. V1 went to the hospital and was diagnosed with a sprained ankle.

V1 told Detective Brennan that on March 7, 2016, at Hansen's residence, she woke up to Hansen straddling her with his pants down and his penis in her face. V1 said that she told Hansen to 'get off me' and Hansen responded 'you are not leaving here until you suck my dick.' V1 said she was able to get Hansen off of her and that he then started freaking out. V1 then used the bathroom and stated when she came back Hansen was on the couch with his pants down. V1 asked for her keys and Hansen responded that the keys were in his pants pocket and she needed to 'suck his dick' before she got them. V1 stated that Hansen had a look in his eye and that she felt that he would physically assault her as he had in the past if she did not perform oral sex on him. V1 stated that she believed that the relationship had become controlling and abusive.

V1 stated that Hansen convinced her to let him fist (put his fist into her vagina) her and that while the act was happening it hurt so bad that she was screaming for Hansen to stop but Hansen refused to stop.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
