The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Assault-3rd Degree-Substantial Bodily Harm

Minnesota Statute: 609.223.1

Maximum Sentence: 5 years and/or \$10,000

Offense Level: Felony

On or about July 4, 2016, in the County of Blue Earth, said Defendant, Brandon Dewaine Thornburg-Spear did, assault another and inflicted substantial bodily harm.

STATEMENT OF PROBABLE CAUSE

On July 5, 2016, Blue Earth County Jail staff advised Deputy Bill Davis, of the Blue Earth County Sheriff's Office, of an assault that had occurred in the Alpha Unit on July 4, 2016.

Deputy Davis was provided a copy of Custody Officer Brian Schroeder's incident report. In Schroeder's report he states that Brandon Thornburg-Spear and Victim1 are seen walking around the Alpha Unit when Thornburg-Spear suddenly hits Victim1 in the face with a closed fist.

Both individuals then began to exchange punches until jail staff responded and separated them. Victim1 received a broken nose, a left black eye, and a laceration to his forehead. Victim1 was transported to the emergency department for treatment. According to Victim1 and jail staff, the laceration on Victim1's forehead required numerous sutures to close. Jail staff who accompanied Victim 1 to the emergency room also stated that Victim1's nose was broken.

Following the assault, jail staff members inquired of Thornburg what the fight was about. Thornburg stated that the incident was the result of some issues both he and Victim1 had from the streets.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.

Complainant declares under penalty of perjury that everything stated in this document is true and correct. Minn. Stat. § 358.116; Minn. R. Crim. P. 2.01, subds. 1, 2.
