COMPLAINT

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Domestic Assault-Misdemeanor-Intentionally Inflicts/Attempts to Inflict Bodily Harm on Another

Minnesota Statute: 609.2242.1(2)

Maximum Sentence: 90 days or \$1,000 fine, or both.

Offense Level: Misdemeanor

Offense Date (on or about): 02/01/2023

Control #(ICR#): 23000186

Charge Description: On or about February 1, 2023, in the County of Blue Earth, Minnesota, Natalie Elizabeth Bruemmer, did, against a family or household member, as defined in M.S.A. 518B.01 Subd. 2, intentionally inflict or attempt to inflict bodily harm upon another.

COUNT II

Charge: Obstruct Legal Process-Interfere w/Peace Officer

Minnesota Statute: 609.50.1(2)

Maximum Sentence: 90 days or \$1,000 fine, or both.

Offense Level: Misdemeanor

Offense Date (on or about): 02/01/2023

Control #(ICR#): 23000186

Charge Description: On or about February 1, 2023, in the County of Blue Earth, Minnesota, Natalie Elizabeth Bruemmer did, intentionally, obstruct, resist, or interfere with a peace officer while the officer is engaged in the performance of official duties.

STATEMENT OF PROBABLE CAUSE

On February 1, 2023 at 7:30 p.m., Officers of the Eagle Lake Police Department were dispatched in response to Victim's 911 call saying he needed assistance. Loud yelling was heard in the background. Officer Guillemette arrived to Victim's residence in Blue Earth County. Prior to entering the residence, Officer Guillemette could hearing yelling from inside the residence. Inside the residence, Officer Guillemette located Natalie Elizabeth Bruemmer (DOB 04/05/1986), who also was staying at the residence. Bruemmer had a body only warrant out of Brown County.

Deputy Suckow and Officer Guillemette attempted to place Bruemmer under arrest. She became aggressive and began pulling her hands away from the officers requiring multiple attempts to place Bruemmer in handcuffs. While Bruemer was being escorted out of the residence, she continued to yell, attempted to pulls her arms away from offices, and she kicked her legs around. Bruemmer eventually calmed down.

Victim told Officer Guillemette that while driving home from the bar Bruemmer was hitting him and spitting in his face. Once they arrived at home, Bruemmer hit him with a whole chicken in the back of his head. Victim still had some chicken residue in his hair.

Bruemmer has pending domestic assault charges in which she is previously alleged to have assaulted Victim in Court file 07-CR-21-4409.

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
