The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Disorderly Conduct-Brawling or Fighting

Minnesota Statute: 609.72.1(1)

Maximum Sentence: 90 days and/or \$1,000

Offense Level: Misdemeanor

Offense Date (on or about): 09/09/2016

Control #(ICR#): 16027263

Charge Description: Said Defendant, Craig Allen Bailey, did in a public or private place, knowing, or having reasonable grounds to know that it will, or will tend to, alarm, anger or disturb others or provoke an assault or breach of the peace, engaged in brawling or fighting.

STATEMENT OF PROBABLE CAUSE

Complainant is an Officer with the Mankato Police Department who believes the information set out below is true and accurate based on reports and information submitted to the Officer by Officer Jacob Price and others identified herein.

On September 9, 2016, at approximately 8:15 a.m., Officer Price responded to a report of an assault at a residence in the City of Mankato, Blue Earth County, Minnesota. Officer Price reported to that location and identified the victim as Victim 1. Victim 1 indicated that he had been struck by another individual that was later identified as Craig Allen Bailey, the Defendant herein. Victim 1 claimed that the Defendant struck him for no reason. Officer Price spoke with the Defendant regarding the incident. The Defendant claimed that the victim had assaulted his ex-girlfriend. The Defendant acknowledged that he punched Victim 1 in the side of the head. Officer Price spoke with Victim 1 a second time. Victim 1 denied assaulting the Defendant's girlfriend.

A computer check of the Defendant's criminal history indicates that he has a pending Theft and Tampering with a Motor Vehicle charge in Blue Earth County from an incident on September 16, 2016. See Blue Earth County District Court File 07-CR-16-3744.
