COMPLAINT

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Violate No Contact Order - Within 10 years of the first of two or more convictions

Minnesota Statute: 629.75.2(d)(1)

Maximum Sentence: 5 years and/or \$10,000

Offense Level: Felony

Offense Date (on or about): 06/26/2016

Control #(ICR#): 16018874

Charge Description: Wade Andrew Gordon Also Known As Wade A Gordon

On or about June 26, 2016, in the County of Blue Earth, said Defendant, Wade Andrew Gordon did violate a Domestic Abuse No-Contact Order and the respondent or person to be restrained knew of the existence of the order and the violation occurred during the time period between two previous qualified domestic violence-related offense convictions and the end of the ten years following discharge from sentence for those offenses.

STATEMENT OF PROBABLE CAUSE

On June 26, 2016 at approximately 3:23 PM Officer Kelly Wood with the Mankato Department of Public Safety responded to report that Wade Andrew Gordon had violated a Domestic Assault No Contact Order (DANCO). Victim 1 is the protected party of the DANCO. The DANCO arises from Blue Earth County file number 07'CR'14'3634 and states that Gordon may have 'no contact directly, indirectly or through others, in person, by telephone, in writing, electronically or by any other means with the protected person(s) named above.' Furthermore the Order states 'You may not go to the following location(s): residence of the victim.' The order was signed by a judge of District Court on December 1, 2014, the same day in which Gordon was served with the Order.

Officer Wood went to the residence of Victim 1 who stated that she had been assaulted by her ex-boyfriend, Gordon. Victim 1 stated that she and Gordon had been drinking and relaxing in the family room of her house when Gordon became angered and began swearing and yelling at her stating 'you fucking bitch.' Victim 1 stated she responded by telling Gordon she was going to call 911. Victim 1 reported that Gordon then used an open hand slap her and push her face backwards. Victim 1 reported that Gordon used a closed fist to punch her under her chin. Victim 1 stated she attempted to fight back and defend herself but when she raised her fists Gordon grabbed both of her arms and pushed her backwards and she fell onto the ground.

Victim 1 stated she managed to get away from Gordon and go to the neighbor's house to ask for help however no one was home. Victim 1 stated she observed Gordon exit the residence and ride a bike westbound down E. Main St. Victim 1 stated that as Gordon rode the bike past her he yelled 'fuck you! You fucking bitch!'

A review of Gordon's criminal history shows at least three convictions for qualified domestic violence-related offenses. In January 2011 Gordon was convicted of felony domestic assault under Blue Earth County file number 07'CR'11'71. In September of 2012 Gordon was convicted of 4th degree assault in Blue Earth County file number 07-CR-12-3282. In October 2014 Gordon was convicted of stalking in Blue Earth County file number 07'CR'14'3634.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
