COMPLAINT

Summons

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Domestic Abuse - Violate Order for Protection-Misdemeanor

Minnesota Statute: 518B.01.14(b)

Maximum Sentence: 90 days and/or \$1,000

Offense Level: Misdemeanor

Offense Date (on or about): 10/13/2016

Control #(ICR#): 16001126

Charge Description: Derrick Alan Dootson

On or about October 13, 2016, in the County of Blue Earth, said Defendant, Derrick Alan Dootson did violate an order for protection granted by a judge or referee.

COUNT II

Charge: Domestic Abuse - Violate No Contact Order-Misd.

Minnesota Statute: 629.75.2(b)

Maximum Sentence: 90 days and/or \$1,000

Offense Level: Misdemeanor

Offense Date (on or about): 10/13/2016

Control #(ICR#): 16001126

Charge Description: Derrick Alan Dootson

On or about October 13, 2016, in the County of Blue Earth, said Defendant, Derrick Alan Dootson did violate a Domestic Abuse No-Contact Order and the respondent or person to be restrained knew of the existence of the order.

STATEMENT OF PROBABLE CAUSE

On October 13, 2016, at approximately 7:25 p.m., Officer Larson responded to a report of multiple violations of an OFP in the City of Amboy, Blue Earth County, Minnesota. Officer Larson identified the victim as Victim 1. Officer Larson verified that Victim 1 has an OFP on her behalf against another individual, later identified as Derrick Alan Dootson, the defendant herein. Victim 1 reported that the defendant had called her on multiple occasions between October 7, 2016 and October 13, 2016. The OFP prohibits contact by the defendant with Victim 1 'whether in person, with or through other persons, by telephone, mail, email, through electronic devices, social media, or by any other means.' The OFP is found in Blue Earth County District Court File 07-FA-16-3466. The OFP was personally served upon the defendant on September 6, 2016 by Anoka County Sheriff's Deputy Eddy Rice.

Victim 1 stated that the defendant has two sisters that live near each other in Spring Lake Park. Victim 1 suspected that the defendant was calling from his sisters' telephones. Victim 1 said that she suspected that when the cops show up at one of the residences, he sneaks over to the other sister's house. Victim 1 recorded a telephone conversation with the defendant. Victim 1 allowed Officer Larson to record the voicemail message on her cell phone. Victim 1 indicated that she has changed her telephone number but believes her son has given the defendant the new telephone number. Victim 1 said

A computer check of the defendant's pending criminal history indicates that he has a pending Felony level False Imprisonment charge against him in Blue Earth County involving the same victim. See Blue Earth County District Court File 07-CR-16-3121. The DANCO Order was issued as a result of the Felony offense. In addition, the defendant has a pending Misdemeanor OFP and DANCO violations in Blue Earth County as well. See Blue Earth County District Court File 07-CR-16-3775.
