COMPLAINT

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Giving Peace Officer False Name-of Another Person

Minnesota Statute: 609.506.2

Maximum Sentence: 1 year and/or \$3,000

Offense Level: Gross Misdemeanor

Offense Date (on or about): 10/19/2016

Control #(ICR#): 16031731

Charge Description: Duop Pidor

On or about October 19, 2016, in the County of Blue Earth, said Defendant, Duop Pidor did, with intent to obstruct justice, give the name and date of birth of another person to a peace officer when that officer makes inquiries incident to a lawful investigatory stop or lawful arrest, or inquiries incident to executing any other duty imposed by law.

COUNT II

Charge: Drugs - Possession of Drug Paraphernalia - Use or Possession Prohibited

Minnesota Statute: 152.092(a)

Maximum Sentence: \$300

Offense Level: Petty Misdemeanor

Offense Date (on or about): 10/19/2016

Control #(ICR#): 16031731

Charge Description: Duop Pidor

On or about October 19, 2016, in the County of Blue Earth, said Defendant, Duop Pidor did knowingly or intentionally possess drug paraphernalia; to wit: a smoking device

STATEMENT OF PROBABLE CAUSE

On October 19, 2016 at approximately 12:38 p.m., officers were dispatched to a residence on Knoll Lane in Mankato, Blue Earth County, on a report of narcotics violation. Officers located a vehicle at that address and found 2 males inside, including a male later identified as Duop Pidor, the defendant, in the passenger seat. The defendant was pulling papers out of the glove compartment, placing them on top of a small, multicolored pipe, in an attempt to hide the paraphernalia. Officer Mohammed removed the defendant from the vehicle and placed him in the officer squad car. The officer requested identification from the defendant and the defendant provided the name and date of birth of another person. Meanwhile officer Gilbertson searched the vehicle the defendant had been seated in and located the defendant's wallet containing two identification cards. One was a Minnesota identification card with the same name and date that the defendant used to identify himself. The 2nd card was a federal immigration card containing the defendant's correct name and date of birth. Officer Mohammed asked the defendant about the identification cards and the defendant admitted that his real name was Duop Pidor and not the name he previously gave the officer. He admitted he lied because he believed he had an active warrant for his arrest. The defendant also admitted that the false name and date of birth he earlier gave to the police officer belonged to his cousin.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
