COMPLAINT

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Fugitive from Justice from Other State

Minnesota Statute: 629.13

Maximum Sentence: Custody Pending Extradition

Offense Level: Felony

Offense Date (on or about): 11/18/2015

Control #(ICR#): 15016237

Charge Description: Dylan Delbert Grossell

On or about November 18, 2015, in the County of Blue Earth, said Defendant, Dylan Delbert Grossell, is a fugitive from justice in that Dylan Delbert Grossell is present in Blue Earth County, Minnesota and have been charged with the commission of a crime in any other state and having fled from justice, or having been convicted of a crime in another state and having escaped from confinement, broken the terms of bail, probation, or parole, and the State of Wisconsin has issued a warrant for the defendant's arrest and demanded the defendant's return.

STATEMENT OF PROBABLE CAUSE

Your Complainant and/or Signing Officer designated below, being duly sworn, has reviewed the police reports relating to the above ' named Defendant and the allegations contained herein, and/or has spoken with peace officers having knowledge of the incident, and based upon that information, please the following to be true and correct.

The Defendant DYLAN DELBERT GROSSELL (6/19/1992), was placed on probation on December 5, 2013 for the offense of Strangulation and Suffocation, Domestic Abuse in violation of Wisconsin statutes 940.235 (1) and 968.075(1)(a)1. Violation of Wisconsin statute 940.235 (1) is a class H felony. A Violation Warrant was issued on November 18, 2015 by the State of Wisconsin Department of Corrections.

The Defendant is currently in the custody of the State of Minnesota at the Blue Earth County jail. The State of Wisconsin has confirmed that they will extradite the Defendant from Minnesota.

PLEASE TAKE NOTICE: Pursuant to Minn. Stat. 609.49, intentional failure to appear for duly scheduled court appearances may result in additional criminal charges, and in addition to any arrest warrant that may be otherwise issued by the Court.
