COMPLAINT

Summons

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Traffic-DL-Driving after cancellation-inimical to public safety

Minnesota Statute: 171.24.5

Maximum Sentence: 1 year and/or \$3,000

Offense Level: Gross Misdemeanor

Offense Date (on or about): 10/13/2016

Control #(ICR#): 16031075

Charge Description: Said Defendant, Scott Allen Pritchard, Also Known As Scott Pritchard, Scott Allen Pritchard And Scott Allan Pritchard, did after being given notice, or reasonably should have known of the cancellation, disobeyed the order by operating in this state any motor vehicle, the operation of which requires a valid driver's license, while her/his license or privilege was canceled; and the Commissioner of the Department of Public Safety has determined that the operation of a motor vehicle on the highways by the person would be inimical to the public safety or welfare.

STATEMENT OF PROBABLE CAUSE

Complainant is an Officer with the Mankato Police Department who believes the information set out below is true and accurate based on reports and information submitted to the Officer by Officer Adam Kruger and others identified herein.

On October 13, 2016 at approximately 12:25 a.m., Officer Kruger observed a vehicle parked in the alley behind businesses near the intersection of N. 6th St. and Madison Avenue, in Mankato, Blue Earth County. The officer stopped to investigate in the vehicle immediately took off. The officer caught up to the vehicle and ran the registration learning that the registered owner had a warrant for his arrest. Officer Kruger stopped the vehicle and identified the driver as Scott Allen Prichard, the defendant. Officer Kruger ran a check on the defendant's driving record and found that his privileges were canceled as inimical to public safety.
