The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Giving Peace Officer False Name-of Another Person**

Minnesota Statute: 609.506.2

Maximum Sentence: 1 year and/or \$3,000

Offense Level: Gross Misdemeanor

Offense Date (on or about): 10/15/2015

Control #(ICR#): 15032427

Charge Description: Stephen Demetrius Devaughn

On or about October 15, 2015, in the County of Blue Earth, said Defendant, Stephen Demetrius Devaughn did, with intent to obstruct justice, give the name and date of birth of another person to a peace officer when that officer makes inquiries incident to a lawful investigatory stop or lawful arrest, or inquiries incident to executing any other duty imposed by law.

## STATEMENT OF PROBABLE CAUSE

On October 15, 2015, at approximately 9:15 p.m., officers from the North Mankato Police Department, as well as the Mankato Department of Public Safety, were dispatched to a disturbance at the Budget Host Inn on Range Street in the City of Mankato. Officer Gary Schnorenberg of the Mankato Department of Public Safety was one of the officers who responded. While in route, he heard that North Mankato officers had stopped a van leaving the hotel with four suspects from the disturbance in it.

Officer Schnorenberg stopped with the traffic stop and was informed that they were having trouble getting the occupants identified because three of the passengers did not have any ID on them, and they were changing their stories about what state their ID was from. Officer Schnorenberg assisted by speaking with the back seat passenger.

This passenger had given the North Mankato police officers the name of Christopher Jarrod Devaughn and a date of birth of December 25, 1996. The name was coming back as "not on file." Officer Schnorenberg asked Devaughn for his legal name and date of birth, and Devaughn responded by stating Stephen Demetrius Devaughn with a date of birth of July 12, 1995. Devaughn insisted this was his real name and date of birth and claimed to have an ID card in his hotel room at the Budget Host Inn. Officer Schnorenberg asked Devaughn who Christopher was and why he had used his name. Devaughn stated that Christopher was his brother, and he did not know why he lied and used his brother's name.

Officer Schnorenberg then drove Devaughn over to the Budget Host Inn where Devaughn had been staying. Once inside Devaughn's room, Officer Schnorenberg opened a drawer and pulled out a wallet containing a Maryland ID card for Stephen Demetrius Devaughn with a date of birth of July 12, 1995, with a photograph that matched Devaughn.

## SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:  
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or  
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
