**COMPLAINT**

Summons

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: False Fire Alarms/Tamper w/Fire Alarm System-Bodily Harm**

Minnesota Statute: 609.686.2

Maximum Sentence: 5 years and/or \$10,000

Offense Level: Felony

Offense Date (on or about): 10/21/2016

Charge Description: Mark Warren Pritchard Also Known As Mark Warren Pritchad, Mark Pritchard, Mark Warren Pritchard, Mark E Pritchard And Mark Warren Prichard

On or about October 21, 2016, in the County of Blue Earth, said Defendant, Mark Warren Pritchard did, intentionally give a false alarm of fire, or unlawfully tamper or interfere with any fire alarm system, fire protection device, or the station or signal box of any fire alarm system or any auxiliary fire appliance, or unlawfully breaks, injures, defaces, or removes any such system, device, box or station, or unlawfully breaks, injures, destroys, disables, renders inoperable, or disturbs any of the wires, poles, or other supports and appliances connected with or forming a part of any fire alarm system or fire protection device or any auxiliary fire appliance and knew or had reason to know that the tampering would create the potential for bodily harm or the tampering resulted in bodily harm.

**COUNT II**

**Charge: Damage to Property-3rd Deg-Reduce Value \$501-\$1000**

Minnesota Statute: 609.595.2(a)

Maximum Sentence: 1 year and/or \$3,000

Offense Level: Gross Misdemeanor

On or about October 21, 2016, in the County of Blue Earth, said Defendant, Mark Warren Pritchard did intentionally cause damage to another person's physical property without the other person's consent, and the damage reduced the value of the property by more than \$500.00 but no more than \$1,000.00 as measured by the cost of repair and replacement.

## STATEMENT OF PROBABLE CAUSE

On October 21, 2016, at approximately 6:03 p.m., Deputy Dan Gabler of the Blue Earth County Sheriff's Office was in his office doing paperwork when the fire alarm went off. Deputy Gabler was informed that an inmate, later identified as Mark Warren Pritchard, D.O.B. 6-4-1963, had damaged the sprinkler head in his cell. Upon arriving at the scene, Deputy Gabler spoke with jail staff who stated that Pritchard had threatened earlier to break the sprinkler head in his cell.

Jail Officer Haglund was working in the quad units for his shift. Jail Officer Haglund had been pre-briefed previous to his shift that Pritchard had been threatening to break the sprinkler in C103. Officer Haglund reported that after meal pass, at approximately 5:55 p.m., Pritchard intercommed the desk, threatening that the "water works is going to start." At approximately 6:03 p.m., the sprinkler head was broken. Officers went to Pritchard's cell. At that time, Pritchard continued to threaten that it will keep happening and that he will do it again that same evening. Jail staff found some sharp plastic pieces that appeared to be ground down that were in the cell that would have damaged the sprinkler to cause it to break and activate.

Blue Earth County estimates the cost of the damage to be \$880.50.

(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
