COMPLAINT

Warrant

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Violate No Contact Order - Within 10 years of the first of two or more convictions

Minnesota Statute: 629.75.2(d)(1)

Maximum Sentence: 5 years and/or \$10,000

Offense Level: Felony

Offense Date (on or about): 03/26/2016 to 04/14/2016

Control #(ICR#): 16005076

Charge Description: Denerio Dennis Hill Also Known As Dennerio Dennis Hill

On or between March 26, 2016 and April 14, 2016, in the County of Blue Earth, said Defendant, Denerio Dennis Hill did violate a Domestic Abuse No-Contact Order and the respondent or person to be restrained knew of the existence of the order and the violation occurred during the time period between two previous qualified domestic violence-related offense convictions and the end of the ten years following discharge from sentence for those offenses.

STATEMENT OF PROBABLE CAUSE

On April 18, 2016 approximately 1:28 PM Deputy Don Gabler of the Blue Earth County Sheriff's Office was notified by a Blue Earth County probation agent that a Domestic Assault No Contact Order (hereinafter DANCO) was violated by Denerio Dennis Hill. Hill made contact with Victim 1 in violation of a valid DANCO.

The DANCO, which was signed by a judge of the Fifth Judicial District, was signed on March 14, 2016 and served upon Hill on the same date. The Order provides that Hill is to have 'no contact directly, indirectly or through others, in person, by telephone, in writing, electronically or by any other means' with Victim 1. The probation agent informed Deputy Gabler that on at least four occasions Hill had contacted Victim 1 via telephone while Hill was at the jail. Jail phone calls are recorded.

During the first three conversations Hill spoke with Victim 1 regarding a number of subjects. During the fourth conversation Hill stated to his children 'tell Mama to call the lawyer and recant, if she recant I'll be home by the 20th.'

The conversations took place on the following dates:

March 26, 2016 at 3:31 PM

March 28, 2016 at 6:26 PM

April 1, 2016 at 3:10 PM

April 14, 2016 at 12:26 PM

A check of Hill's criminal history shows at least two convictions for qualified domestic violence ' related offenses. The first such conviction can be found in Blue Earth County file 07 ' CR ' 07 ' 3569 a conviction for third-degree assault from August 2007. The second such conviction can be found in Blue Earth County file 07 ' CR ' 15 ' 453 a conviction for domestic assault from February 2015.

Hill is currently in the Blue Earth County Jail; a warrant for his arrest is requested.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
