The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Traffic-DL-Driving after cancellation-inimical to public safety

Minnesota Statute: 171.24.5

Maximum Sentence: 1 year and/or \$3,000

Offense Level: Gross Misdemeanor

Offense Date (on or about): 08/11/2016

Control #(ICR#): 16011762

Charge Description: Randall William Cline

On or about August 11, 2016, in the County of Blue Earth, said Defendant, Randall William Cline did after being given notice, or reasonably should have known of the cancellation, disobeyed the order by operating in this state any motor vehicle, the operation of which requires a driver's license, while her/his license or privilege was cancelled; and the Commissioner of the Department of Public Safety has determined that the operation of a motor vehicle on the highways by the person would be inimical to the public safety or welfare.

COUNT II

Charge: Traffic Regulation-Uninsured Vehicle-Driver Violation

Minnesota Statute: 169.797.3, with reference to: 169.797.4(a)

Maximum Sentence: 1 year and/or \$3,000

Offense Level: Gross Misdemeanor

On or about August 11, 2016, in the County of Blue Earth, said Defendant, Randall William Cline, did

operate a vehicle upon a public highway, street, or road in this state and knows or has reason to know that the owner does not have security complying with the terms of section 65B.48 in full force and effect; and said Defendant violated this section within ten years of the first of two prior convictions under this section, section 169.791, or a statute or ordinance in conformity with one of those sections.

COUNT III

Charge: Traffic Regulation - Motorcycle - Driving without endorsement

Minnesota Statute: 169.974.2(a)

Maximum Sentence:

Offense Level: Petty Misdemeanor

Offense Date (on or about): 08/11/2016

Charge Description: Randall William Cline

On or about August 11, 2016, in the County of Blue Earth, said Defendant, Randall William Cline, did operate a motorcycle on any street or highway without having a valid standard driver's license with a two-wheeled vehicle endorsement.

COUNT IV

Charge: Traffic - Speeding - Exceed Limit 55 mph Where Appropriate

Minnesota Statute: 169.14.2(a)(3)

Maximum Sentence: Not more than \$300

Offense Level: Petty Misdemeanor

Offense Date (on or about): 08/11/2016

Control #(ICR#): 16011762

Charge Description: Randall William Cline

On or about August 11, 2016, in the County of Blue Earth, said Defendant, Randall William Cline, did operate a motor vehicle in excess of the posted speed limit; to wit: 71 mph in a 55 mph speed zone.

STATEMENT OF PROBABLE CAUSE

On August 11, 2016 at approximately 3:57 PM, Deputy Arkell was traveling southbound on County Road 28 near County Rd 23 in Blue Earth County. He noticed a motorcycle, traveling northbound, at a high rate of speed. The radar unit in the deputy's squad clocked the motorcycle traveling at 71 miles per hour in a 55 mile per hour zone. Deputy Arkell pulled the vehicle over and it pulled into a driveway along County Road 28. Deputy Phillips assisted in the stop and identified the driver as Randall William Cline, the defendant, from previous law enforcement contacts. The defendant admitted that his driving privileges were canceled as inimical to public safety and that he did not have insurance on the motorcycle. He also acknowledged that he was speeding. The deputy ran the defendants driving record and found that the defendant did not have a motorcycle endorsement. The defendant has a prior conviction for no insurance in 2012 and two prior convictions for no proof of insurance in 2012 and in 2014.

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
