COMPLAINT

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Drugs - 5th Degree - Possess Schedule 1,2,3,4 - Not Small Amount Marijuana

Minnesota Statute: 152.025.2(a)(1)

Maximum Sentence: 5 years and/or \$10,000

Offense Level: Felony

Offense Date (on or about): 07/28/2016

Charge Description: Clifford Francis Freiderich, III Also Known As Clifford Freiderich, Clifford Francis Freiderich, Clifford Frances Freiderich And Clifford Francis Freidrich

On or about July 28, 2016, in the County of Blue Earth, said Defendant, Clifford Francis Freiderich, III did unlawfully possess one or more mixtures containing a controlled substance classified in schedule I, II, III, or IV, except a small amount of marijuana.

COUNT II

Charge: Introduce Contraband-Drug/Liquor into Jail/Lockup/Prison

Minnesota Statute: 641.165.2(a)

Maximum Sentence: 1 year and/or \$3,000

Offense Level: Gross Misdemeanor

Offense Date (on or about): 07/28/2016

Control #(ICR#): 16010987

Charge Description: Clifford Francis Freiderich, III Also Known As Clifford Freiderich, Clifford Francis Freiderich, Clifford Frances Freiderich And Clifford Francis Freidrich

On or about July 28, 2016, in the County of Blue Earth, said Defendant, Clifford Francis Freiderich, III did

introduce or in any manner caused the introduction of contraband into any jail, lock-up, or correctional facility, without the consent of the person in charge, or is found in possession of contraband while within the facility or upon the grounds thereof.

STATEMENT OF PROBABLE CAUSE

On July 28, 2016 at approximately 7:54 PM Deputy Don Gabler with the Blue Earth County Sheriff's Office received a call about possible narcotics violation in the Blue Earth County jail.

Deputy Gabler proceeded to the jail and spoke with Sergeant Jay Hueper who stated that Clifford Francis Freiderich had been on a furlough from jail to see a family member who was sick. Sergeant Heuper stated that he had information that Freiderich was possibly going to try to smuggle illegal contraband into the jail. The jail staff informed Freiderich that they would do a urine test before he left and when he came back.

Sergeant Heuper stated that when Freiderich arrived back at the jail, staff asked him for a strip search. Sergeant Heuper asked Freiderich to bend over and Sergeant Heuper noticed a purpleish/blue type object in Freiderich's rectal area.

Sergeant Heuper handed Deputy Gabler a baggie with a purpleish blue balloon or rubber finger type material with something inside of it. Sergeant Heuper stated that Freiderich told him it was methamphetamine.

Deputy Gabler took the bag back to the evidence room and cut it open where he found a smaller baggie which contained a white crystal substance that field-tested positive for the presence of methamphetamine. Weight of the methamphetamine with the bag that it was in was .6 g.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
