The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Traffic-DL-Driving after cancellation-inimical to public safety**

Minnesota Statute: 171.24.5

Maximum Sentence: 1 year and/or \$3,000

Offense Level: Gross Misdemeanor

Offense Date (on or about): 01/21/2016

Control #(ICR#): 16001963

Charge Description: Said Defendant, Jerry Lee Hargreaves, did unlawfully operate a motor vehicle, the operation of which requires a valid driver's license, upon a public highway within the State of Minnesota at a time when his privilege to operate a motor vehicle was canceled inimical to public safety.

**COUNT II**

**Charge: Traffic Regulation-Uninsured Vehicle-Owner Violation**

Minnesota Statute: 169.797.2

Maximum Sentence: 90 days and/or \$1,000

Offense Level: Misdemeanor

Offense Date (on or about): 01/21/2016

Control #(ICR#): 16001963

Charge Description: Said Defendant, Jerry Lee Hargreaves, being the owner or driver of a vehicle for which security is required, did unlawfully operate or permit the vehicle to be operated, on a public highway, street or road in this state, and who knows or has reason to know the vehicle does not have security complying with the terms of Minnesota Statutes.

## STATEMENT OF PROBABLE CAUSE

Complainant is an Officer with the Mankato Police Department who believes the information set out below is true and accurate based on reports and information submitted to the Officer by Officer Sean McClinton and others identified herein.

On January 21, 2016, at approximately 2:20 p.m., Officer McClinton observed a vehicle with an obstructed license plate tab being driven near 1150 South Victory Drive in the City of Mankato, Blue Earth County, Minnesota. Officer McClinton ran the license plate of the vehicle and determined that the plates were impounded due to alcohol. A computer check of the vehicle's license plates indicated that the registered owner was Cancelled-IPS. Officer McClinton notes in his report that the operator of the vehicle fit the description of the registered owner. Officer McClinton stopped the vehicle and identified the driver as Jerry Lee Hargreaves, the Defendant herein. A computer check of the Defendant's driver's license record indicates that it was canceled as inimical to public safety at the time of this incident. Officer McClinton asked the Defendant for proof of insurance. The Defendant responded that there wasn't any insurance.

(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
