COMPLAINT

Summons

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: SPEED 55 ZONE

Minnesota Statute: 169.14.2(a)(3)

Maximum Sentence: \$300 fine

Offense Level: Petty Misdemeanor

Offense Date (on or about): 08/10/2016

Control #(ICR#): 16447528

Charge Description: Mario Forestal

On or about August 10, 2016, in the County of Blue Earth, said Defendant, Mario Forestal did operate a motor vehicle in excess of the posted speed limit; to wit: 70 mph in a 55 mph speed zone.

STATEMENT OF PROBABLE CAUSE

On August 10, 2016, at approximately 3:50 p.m., Trooper Kutz observed a vehicle traveling at a high rate of speed on County Road 90 in Blue Earth County, Minnesota. Trooper Kutz was operating radar speed detection equipment and clocked the vehicle at 70 miles per hour in a 55-mile-per-hour zone. Trooper Kutz stopped the vehicle and identified the driver as Mario Forestal, the Defendant herein. Trooper Kutz spoke with the Defendant regarding the basis of the stop. The Defendant informed Trooper Kutz that he didn't know how fast he was going. Trooper Kutz also noted that the Defendant had an object suspended from his rearview mirror. Trooper Kutz warned the Defendant for the suspended object violation but issued him a citation for speeding of 70 miles per hour in a 55-mile-per-hour zone.
