COMPLAINT

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Domestic Assault-Commits Act to Cause Fear of Immediate Bodily Harm or Death

Minnesota Statute: 609.2242.1(1)

Maximum Sentence: 90 days and/or \$1,000

Offense Level: Misdemeanor

Offense Date (on or about): 06/18/2016

Control #(ICR#): 16008727

Charge Description: Ricardo Arjona Fletcher

On or about June 18, 2016, in the County of Blue Earth, said Defendant, Ricardo Arjona Fletcher did, against a family or household member, as defined in M.S.A. 518B.01 Subd. 2, commit an act with intent to cause fear in another of immediate bodily harm or death.

STATEMENT OF PROBABLE CAUSE

On June 18, 2016, at approximately 7:35 p.m., Deputy Anderson responded to the report of a hang up 911 phone call at a residence in Blue Earth County, Minnesota. Deputy Anderson reported to that area and located a female, later identified as Victim 1. Victim 1 described an incident involving her ex-boyfriend, who was later identified as Ricardo Arjona Fletcher, the Defendant herein. Deputy Anderson notes in her report that Victim 1 was visibly upset and crying. Victim 1 said that she had visited the Defendant after they had recently broken up. Victim 1 went to the Defendant's residence where the Defendant became agitated. Victim 1 wanted to go home because the Defendant was becoming more agitated. The Defendant grabbed Victim 1 by the shirt several times and pushed her against the wall. The Defendant then punched the wall. After the Defendant punched the wall the defendant stated to Victim 1, "I didn't want to do this." Victim 1 reported the Defendant took her cell phone but proceeded to call 911. The Defendant eventually gave Victim 1 her phone back. The Defendant later blocked the front door and wanted to continue to talk to Victim 1. Victim 1 told the Defendant to move several times, and the Defendant eventually did.

A computer check of the Defendant's prior criminal history indicates that he is on probation through Blue Earth County for a felony-level offense. See Blue Earth County District Court file 07-CR-13-3835.

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
